ELLIOTT GREEN: A visit from Ross Galloway of TigerTurf has been very informative. You'll be aware there has been a deterioration in some areas of the Elliott Green surface which is limiting its availability. Repair work will be undertaken before Christmas, but in the meantime players must be diligent in assuring there is no repeat of this damage.

More information will be issued soon, but one immediate action you can take is to, when having a roll up or practice, play to the rink markers rather than the rink numbers and alter your mat placement regularly.

WORKING BEE SUCCESS: Much was achieved in our working bee with a large amount of rubbish removed, including 20 broken chairs, and over half of the lockers sent to a metal recycler. Since then, the men's locker room has been painted and shelving installed. The office is being revamped with fresh paint and shelves. When agreement is reached among our women members as to what is required in their area, action will be taken.

Before then though, **urgent work** is needed to repaint the exterior bench seats. Our Collective Responsibilities for Safe Provision and Consumption of Alcohol

A recent tragic incident highlights that we need to be aware of our responsibilities for safe provision of alcohol and to ensure that we have taken all measures to achieve this.

A Sports Club in the Wellington Region had their Liquor Licence revoked after it failed to recognise that a member drinking at the Club had become grossly intoxicated. That member then drove, caused a fatal accident and has been sentenced to a significant period of imprisonment.

In their decision to revoke the Club's Liquor Licence, the Licencing Authority noted that the Club did not have procedures in place to detect and prevent hazardous drinking and nor had their bar staff, apart from the Manager, had any formal training.

Since then, our Club has had an alcohol licencing inspection. While there are no immediate issues, we, along with other clubs, have been asked to accept an "additional discretionary condition" for operation of the bar. We have until the next inspection in 12 months to demonstrate our progress in adopting this condition, but we wish to fulfil this obligation much sooner than that.

The ideal is that a certificated Manager is present when the bar is open, but this is not always possible, and the Licensing Authorities accept this. However, in the absence of a certificated Manager they require that there must be a nominated "Responsible Person" on duty and their full name must be displayed. This person must have completed ServeWise training or equivalent and be able to show evidence of this when requested.

Failure to observe this condition means that we could be considered to be noncompliant and risk losing our licence. We do not consider that the condition is discretionary, as it falls under section 295 of the Sale and Supply of Alcohol act, "Duty to Collaborate"

We are very grateful to our volunteer bar staff and have discussed with them how we can fulfil this condition of operation. This means that as many of them as possible should do ServeWise training. This takes 2-4 hours online and is free of charge.

We have had a great response, with seven people already having completed ServeWise and several more are in the process of doing so. Well done.

In addition to this, the Board considers that members should have some familiarity with our responsibilities around serving alcohol and suggests that all should read the following resource. For those who cannot access it online, there is a copy in the office.

The document makes clear the requirements that Clubs must observe, especially in recognising intoxication. It also details the potential penalties for various breaches, some of which are severe. All members should be aware of these responsibilities, and we should look out for each other. The hearing in the case of the Club that lost their licence revealed that other members had been buying drinks for the person who caused the accident when it already was obvious that the person was intoxicated. As well as being irresponsible, this was unfair to the bar staff as it did not allow them to easily recognise the amount the person had drunk, nor the level of intoxication.

Let us all be responsible together!
